

**SUPER 14 2010 'TRY SCORER' COMPETITION
TERMS & CONDITIONS**

1. The Competition opens at 9am on Wednesday 10th February 2010 and closes at 5pm on Sunday 16th May 2010 (the **Competition Period**). All entries must be received during the Competition Period.
2. To be eligible to enter this Competition, customers must place a \$5 or more bet on the 'Try Scorer' selection on any of the following bet options on any Super 14 games during the competition period:
 - (a) First Try Scorer,
 - (b) Last Try Scorer
 - (c) To Score a Try
 - (d) Multi bet with at least one 'Try Scorer' selection (where the 'Try Scorer' selection must be worth \$5.00 or more)

Customers may enter the Competition as many times as they place an eligible bet during the Competition Period. An eligible bet is 1 x \$5 or more 'Try Scorer' bet ticket or a 1 x \$5 or more 'Try Scorer' selection included into a Multi bet.

3. There are two ways to enter the competition and they are:
 - (a) **Cash Customers at TAB stores or on-course at the tracks**

Cash customers must purchase a 'Try Scorer' bet from any TAB Retail store or on-course and then log onto tab.co.nz/super14 and register an eligible 'Try Scorer' bet using the on-line entry form provided. Cash customers must provide their full name, contact number, bet type, date purchased bet and serial number of their ticket when registering their entry for the competition (mandatory fields). Only entries that have been completed properly, correctly and accurately (valid entries) will be eligible to win prizes.
 - (b) **Account Customers**

TAB Account customers will automatically be entered into the draw(s) when they place a 'Try Scorer' bet through their TAB Account
4. Board members, employees, agents (and agent's employees) and contractors of the New Zealand Racing Board (**NZRB**) and the Immediate Families of such persons, are not eligible to enter this Competition or to win prizes. "Immediate Family" of a person means the parents, siblings, children and spouse or partner (whether legal or de facto) of that person.
5. Excluded customers of the NZRB are not eligible to win prizes.
6. To be eligible for entry, Customers must reside in New Zealand and be over 18 years of age, and have granted permission for promotional contact by the NZ Racing Board. The NZRB reserves the right to require any customer to produce identification and/or proof of age.
7. Cancelled, refunded and 'Try Scorer' special bets are not eligible for entry into this competition.
8. There are 5 prizes to be won:
 - (a) **First Prize** consist of a 52" HD flat screen TV, one \$500 worth of bets on the 2010 Super 14 Final game, and a signed NZ franchise Super 14 team jersey.

The first prize winner will have the first priority in choosing the NZ franchise Super 14 team jersey. There are 5 signed jerseys to choose from.

- (b) **Second prize** is \$100 worth of bets on the 2010 Super 14 Final and a signed Super 14 jersey from the remaining 4 signed jerseys after the first prize winner have chosen one.
 - (c) **Third Prize** is \$100 worth of bets on the 2010 Super 14 Final and a signed Super 14 jersey from the remaining 3 signed jerseys after the first prize winner and the first runner-up have selected their prizes.
 - (d) **Fourth Prize** is \$100 worth of bets on the 2010 Super 14 Final and a signed Super 14 jersey from the remaining 2 signed jerseys after the first prize winner, the first and second runner-ups have selected their prizes.
 - (e) **Fifth Prize** is \$100 worth of bets on the 2010 Super 14 Final and the last remaining signed Super 14 jersey.
9. Cash customers must retain their 'Try Scorer' bet ticket as proof of purchase as they may be required for confirmation as a prize winner.
 10. The Prizes are not transferable or convertible for other alternatives and cannot be exchanged for cash.
 11. A random draw from all eligible entries will be made on Tuesday 18th May 2010 in the presence of designated NZRB Audit personnel. The final decision in respect of any winning entry will be at the sole discretion of the Head of Risk, Legal & Audit of the NZRB and no correspondence will be entered into.
 12. Customers are responsible for supplying correct contact details. NZRB will contact winners to arrange for delivery of the prizes. If the NZRB is unable to contact the winning customer by 5pm on 20th May 2010, having made reasonable efforts to do so, the winner's entry will be declared invalid and the NZRB reserves the right to randomly redraw another winner on the same terms and conditions as the original draw.
 13. The NZRB takes no responsibility for lost or damaged entry forms or any direct or indirect loss suffered by the winner as part of the Prize.
 14. The NZRB reserves the right to disqualify any customer for tampering with the entry process or attempting to act in a fraudulent or dishonest manner.
 15. In addition to the Super 14 'Try Scorer' Competition draws, customers who subscribed to Odds On e-newsletter are also eligible to participate in the Odds On Bonus Draws.
 16. To be eligible to participate in the Odds On Bonus Prize draws, entrants must have subscribed to the Odds On e-newsletter and have a valid email address in the system on the day of the prize draw. In order to subscribe to the Odds On e-newsletter, you must have a current TAB Betting Account.
 17. The **Odds On Bonus Draw** consists of:
 - (a) **Weekly Draw** – On each Tuesday during the competition period, we will draw a winner, from the eligible entries received from the previous week, to receive a \$32.00 easybet on the following weekend's Rugby League Pools. The last draw will be made on Tuesday, 18 May 2010.
Winner's Prize: Winners will be advised of the \$32.00 easybet placed on their behalf and any winnings from their bets will be deposited directly into their TAB betting account on Monday following the completion of the games.

- (b) **Ultimate Odds On Bonus Draw:** Winners of Weekly Odds On Bonus Draws during the competition period will automatically be included in an ultimate draw to win a 40" HD flat screen TV (Ultimate Prize). There is only one Ultimate Prize to be won. The winner for this prize will be drawn on 18 May 2010.

Winner's Prize: NZRB will contact the Ultimate Winner to arrange for the delivery of the prize. As with clause 10 above, if NZRB is unable to contact the winning customer by 5pm on 20th May 2010, having made reasonable efforts to do so, the winner's entry will be declared invalid and the NZRB reserves the right to randomly redraw another winner on the same terms and conditions as the original draw.

18. The Terms and Conditions of entry expressed under 4 to 7 above also apply to the Odds On Bonus Draws.
19. Entrants drawn to win major prizes in this promotion will be required to sign a declaration to confirm adherence to Terms and Conditions of the competition before they are confirmed as winners.
20. The winner agrees to be involved in any reasonable promotional activities stipulated by the NZRB, including but not limited to photographs and the publication of the winners name.
21. If these Competitions cannot be run as planned for reasons beyond the control of the NZRB, the NZRB reserves the right in its sole discretion to cancel this Competition.
22. The NZRB is not liable for any direct, indirect, special or consequential loss or damage caused to the Winner in relation to the Prize or this Competition.
23. The personal information provided by each customer in entering this Competition will be held in accordance with the Privacy Act 1993. The personal information will be stored on a database and may be used only by the NZRB for conducting the draw, contacting and publishing the winners' names for the Super 14 draws and the Odds On Bonus draws.
24. The NZRB will not sell, disclose or distribute the personal information provided by customers to any person, organisation, agency or other third party. Customers may request access to their information or may request their information be amended or removed from the database by contacting the New Zealand Racing Board.
